I hereby agree to the secondary use or other similar use of works relating to the lecture or presentation specified above (hereinafter referred to as the “Lecture/Presentation”), as follows:

1. Use of Works

- 1-1. I agree on a royalty free basis that the University will use any photograph, video and audio taken or recorded during the Lecture/Presentation, as well as any document and material relating to the Lecture/Presentation including portraits of myself and my works contained therein (hereinafter collectively referred to as the “Works”) in the content services via the internet or by other means which are operated or provided by the University (including UTokyo TV (<http://today.tv/>)) (hereinafter referred to as the “Content Services”), and for the public relations, including the websites, social networking services and posters of the University and UTokyo TV, associated with the Content Services (such use includes making the Works transmittable (i.e. upload) and public transmission, and copy, reproduction, compilation and edit of the Works associated therewith); provided, however, that the scope of the Content Services shall be limited to that available or viewable by the members of the University including its students and faculty members logging in the website of UTokyo TV (i.e. content services limited within the University).
- 1-2. I agree that the University will display in connection with the Content Services my name, affiliation, biography and other relevant information as well as translation of the title and outline of the Lecture/Presentation of the Works and my name, affiliation, biography and other relevant information.
- 1-3. The agreement concerning the matters specified in the items 1-1 and 1-2 above shall be made without a fixed term; provided, however, that I may withdraw such agreement at any time.

2. Handling of My Works

I agree that the University may delete or replace illustrations or other materials contained in my works such as slides for Lecture/Presentation included in the Works by compiling or editing the Works to the extent specified in the item 1-1 above, if such illustrations or other materials are likely to infringe a third party’s right.

3. Responding to Claim

Should any claim (including complaint, lawsuit or other proceeding) be made by any third party in respect of the Works, I will take necessary measures to solve the claim with the Center for Research and Development of Higher Education of the University by providing necessary information to the Center or otherwise. Further, I agree that in the event that an urgent response is required for the claim, the University may suspend the Content Services for the Works without approval from me.

4. Other Matters

In the event that any matter in respect of the Works and/or the use thereof not specified in this Agreement becomes an issue, I will discuss such matter with the Center for Research and Development of Higher Education of the University as appropriate.
